

committee update

Legislative Awareness Committee: Capitol Update

On Oct. 7, the House approved a measure (275-151) that would allow patients to sue their health plan provider, without limit, for deaths or injuries perceived to be the result of poor care or denial of treatment. 68 House Republicans crossed party lines to support the measure which is considered to be a major blow to the insurance industry. The measure also addresses other complaints of patients in HMOs such as access to emergency care, access to certain specialists without approval from primary care physicians, and receiving routine care for clinical trials.

Representatives from the House, Senate and White House will meet to develop a final package of patient protections.

"Has anyone involved in giving rapid boluses of Magnevist for MRI (with injector) noticed a problem with patients developing phlebitis at the IV start sites, especially when started with a saline lock and Insyte? We have had this problem, but not when a butterfly was used."

From: Nancy O'Donoghue <odonoghn@musc.edu> subjects: pharmocologic agents for sedation of older children, and competency of Radiology Nurses for care of the ICU patient.

"IV Seconal is no longer available to use for sedation of the older child. What is everyone else using with success?" also, "since Radiology Nurses assume care of the ICU patient in the Radiology Department I wondered if you could tell me what you are doing to keep your nurses ICU competent. We have difficulty keeping up with the latest skills because we would only have an ICU patient 3-4 times a week. Our ICU managers felt that the radiology nurses would need to rotate through the unit once a month to keep their skills up. Our solution was to have the ICU nurse stay with the patient when they were here. The other issue was whether or not the Radiology nurse could receive enough " acute " care direction from MD's that are not critical care physicians. Last, what is the nursing ratio to allow for one on one nursing for patients from beginning to end.? How late do you staff nurses and how many after 5 pm?

An ethical dilemma:

"For the past two and a half years we have been responsible for the sub-Q or intradermal injections of Tc99m Sulphur Colloid for the pupose of Sentinel Node identification during Lymphoscintography for primary breast carcinoma and melanoma patients. We believed we were covered by department policy and New York State Regulations for "Diagnostic Materials and Radiopharmaceutical Administration" as "other" licensed personnel. Recently, it was brought to our attention that this is indeed "out of the scope of nursing practice" as defined by New York State. I am now faced with the challenge of proving to the state that we Radiology Nurses are indeed able to perform this service for our patients. Are any other Radiology nurses responsible for providing this service? If so, how have you developed your practice. Any input or assisstance would be greatly appreciated."

"I am a new Radiology Nurse in a hospital which has only had such nurses for two years. JCAHO is coming and I need to develop some new policies. We have two nurses in Radiology and one at our outpatient (down the street) MRI. We need written policies on medication storage at the offsite facility, transferring of patients - both stable and unstable, what to do for emergencies, etc.

My question is, are patients routinely positioned supine or Trendelburg for port placements, dialysis catheter, Hickman catheter, etc placements. Any insight or help to reduce this complication would be greatly appreciated." Thank you.
