The Board of Directors hosted the Past President's Reception last evening and I was in awe of the years of ARIN history sitting at the table. Founding member Joanna Po, JoAnn Belanger, Colleen Sasso, Kathleen Gross, Sharon Lehmann, and Karen Green were our honored Past Presidents. I wish we had thought to record the conversation as each past president in attendance gave an overview of her presidency and shared the early history of ARNA. I can't imagine lugging suitcases filled with Board notes, bank statements, agendas, and minutes everywhere they went on Board business! Listening to their stories, I really knew that I could not let these fabulous past leaders, the membership who elected me, the wonderful people who support me, or myself down in my Presidential year.

When I was approached by the Nominating Committee Chair to run for President-Elect, I initially said, flat out "thanks, but no thanks." Committed to Advancing Radiologic and Imaging Nursing will be the theme of the 2013 ARIN Spring Convention. The Board will work closely with Dancy AMC to make both of those member services relevant to you, our valued ARIN member. We will seek out the best resources possible, in order to build that "robust technology program" referred to in Ms. Byers' book. During my Presidency, I am extremely committed to putting resources into the infrastructure of the ARIN organization and our management company so that ARIN may grow and prosper in the future. Outgoing Presidential Address

Distinguished board members, fellow ARIN members, and Dancy Association Management Company:

I would like to begin by thanking all of you for attending this membership luncheon. ARIN is having another great conference. We have 376 people in attendance this year. The high attendance speaks volumes to the dedication that radiology and imaging nurses have to their profession. I have been genuinely honored to serve as your president for the past year.

The theme of this year's convention is "Evolving the Future of Imaging Nursing." Last year when I addressed you as your newly installed president, I used the word "evolve" as an acronym to describe my vision for the coming year. The Encarta Dictionary defines evolve as "to develop something gradually, often into something more complex or advanced." ARIN has definitely evolved since I became a member in 1994. I would like to highlight ARIN's evolution during the past year.

- ARIN initiated a webinar program and held four successful webinars. A webinar committee has been established to lead the development of the ARIN educational webinar program. The live webinars were well-attended and the archived versions have been viewed by many members and non-members. This is another great way to reach members with educational opportunities and provide nursing contact hours specific to radiology and imaging.
- 2. The Radiology Nursing Scope and Standards of Practice, which ARNA published jointly with the ANA five years ago, has been completely updated and revised. The title has even been updated to reflect radiologic and imaging nursing. Very soon, the newly revised draft will be posted on the ARIN website for review and public comment. Please take time to read the document draft and give your input. Publication should take place in the coming months.
- 3. The Core Curriculum for Radiologic and Imaging Nursing, 3rd Edition is in development under the leadership of editor Kathleen Gross. Kathleen reports that the updates are moving along on schedule.
- ARIN partnered with AHRA, the radiology administrators organization, to present a radiology nursing leadership workshop at the AHRA annual meeting in August. Twenty-five radiology

nurse leaders participated in this educational opportunity.

- 5. SIR, AORN, and ARIN are putting the final touches on the Joint Practice Guideline on Sterile Technique during Vascular and Interventional Radiology Procedures. Finalization has come too late to meet the publisher's deadline for the next issue of the *Journal of Radiology Nursing (JRN)*, but the document is slated to appear in the fall issue of *JRN*. The hard work of the intersociety author team over the past two years has resulted in a guideline that will serve as a standard. I would like to especially thank Chris Keough, who has been the ARIN author on the team.
- 6. The Imaging Review Course Master Faculty, led by Kathy Scheffer, has completely updated the course content. The course has been presented at multiple sites over the past year and continues to be successful.
- 7. The 5th Annual Fall Symposium in Las Vegas was a wonderful experience for those in attendance. The educational sessions were great, and we enjoyed the Las Vegas entertainment options. Plans are underway for the 6th Annual Fall Symposium in Pittsburgh. Please make plans to attend.
- 8. The ARIN Board of Directors has worked hard to evolve ARIN into an organization that members will value. Christy Lee and I attended the Nursing Organizations Alliance Fall Summit in November. At this meeting we learned about a book called *The Race for Relevance*. One of the book authors spoke at the meeting and we felt her message was important. Each of the ARIN board members read the book and we discussed this very pertinent information and the ARIN strategic plan at our board meeting on Friday. I believe ARIN is evolving appropriately and this education will assist the board in making decisions to evolve the future of ARIN.

These are just some of the many activities that have happened throughout the year.

I would like to personally thank each of the board members who have served this past year:

- Mag Browne McManus, Immediate Past President–You set the bar high for me to follow your legacy. I have thoroughly enjoyed working with you these past four years.
- Brenda Wickersham, Treasurer-You have provided a constant vigilance over the finances of ARIN in these tough economic times. Knowing that you were alert to the fiscal responsibilities made my year easier. Your work with the Chapters Committee has also been invaluable.
- Cheryl Jaglowski-Ho, Board Member–It has been a pleasure to work with you. Your role as liaison to the Chapters and Awards Committee helped those committees have a very successful year.

ARIN Treasurer's Report




Figure 1 - 2011 ARIN Revenue and Expense Comparison

On behalf of the board of directors and our management association, I am pleased to report that ARIN is experiencing continued financial recovery, stabilization, and projected growth at a time when many organizations are experiencing losses. ARIN remains committed to growing lean and green. Management and leadership work together to conserve our resources. Fig. 1 illustrates that our revenues exceed our expenses by a margin of \$21,081. This is an improvement from 2009, when our expenses exceeded revenue by \$13,678 and from 2008, when our expenses exceeded revenue by \$39,977.

ARIN revenues grow from membership fees, journal and publications income, and ARIN Foundation certificates of deposit (CDs). The journal income of \$63,159 is a tribute to the work that the *Journal of Radiology Nursing (JRN)* editor and editorial staff have accomplished. Foundation CDs are re-invested as they mature at the highest possible rates, and provide the highest possible return. Funds are diverted to various institutions, thus securing monies within federally insured guidelines.

The ARIN Board of Directors works for you to review the budget line by line with Dancy Association Management Company to predict income and expenses, and perform ongoing planning, monitoring, and revising of the budget. We respect the confidence that you have placed in us as your professional association, and value the time and financial contributions that you invest in ARIN.

Convention and fall symposia remain an invaluable opportunity for staying current in our professional discipline and in working with our peers to improve practice and standards of care. We remain committed to providing high quality educational opportunities. The convention and fall symposium are sources of revenue, though costs associated with conferences once again exceed revenue this year (see fig. 3-4). There are a number of reasons for this and the best future decisions are made through understanding some of the financial undertakings of conference planning. Site selection for convention is made by SIR and the sites are generally expensive. There are some strategies that leadership and membership are encouraged to embrace to keep this work financially feasible. Leadership is initiating a focused technology sponsorship program to provide additional sources of income at the conference and symposium. Relative to hotel costs, we all must consider that a block of rooms is reserved for attendees. Not meeting the room quota that is organized by meeting space, adds additional costs to the association. Membership is encouraged to reserve rooms at the event hotel. Leadership strives to obtain the best possible rates. If you desire to share a room and don't have a roommate, contact us at conference time. We'll work to help you.

An increase in expense for technology has been made in order to offer webinars this year as an affordable educational activity in direct response to membership request.

In another area, leadership decisions to cut printing and shipping costs through publishing handouts on-line have also had a positive impact on the amount of materials that are packed for the return trip home, decreasing baggage weight. Lunch is made available at convention in the Exhibit Hall. Not many attendees would guess that the cost of providing coffee service at conference runs \$109/gallon. This is up from \$90/gallon last year.




Figure 2 - 2011 ARIN Revenues




Figure 3 - ARIN 2011 Expenses




Figure 4 – 5-Year Comparison of ARIN Revenues and Expenses





Figure 5 - ARIN Convention Trends over the past 6 years





Figures 5 and 6 review conference and symposium registrations over the past 5-6 years. Our highest attendance peaked at 530 in 2006 with our 25th anniversary celebration in Las Vegas. (This is the only year that our annual convention did not coincide with the SIR site. Note that this was also the year that we experienced the highest revenue.) We look forward to the 2012 Fall Symposium in Pittsburgh and the 2013 Annual Convention in New Orleans.

In closing, I'd like to stress that you, the ARIN member, are the real treasure of our association. It is through your active participation, whether it be at the local, regional, national, or international level, that the Association for Radiological and Imaging Nursing realizes its goals of maintaining quality patient care. I challenge you to consider the impact we could make if each of us brought one or two new members to the table.... through participation at local chapter and regional events, or and nationally at the Fall Symposium and Annual Convention. Let's keep our organization strong as we remain *committed* to ARIN, the organization for our professional practice.

Health Care Advocacy: Should It Be Left up to Congress?

What can an RN do?

As the public policy representative for the Association for Radiologic and Imaging Nurses, I am proud to announce that there are two ARIN members who have volunteered for representation in public policy. Flora Enaje is the 2nd year member, and I am the 1st year member. The first year member is sent to NIWI (Nurse in Washington Internship). I had the opportunity to attend as a representative of ARIN and it was an eyeopening experience.

The meeting is sponsored by The Nursing Organizations Alliance, of which ARIN is a proud member. The Alliance is a coalition of nursing organizations united to create a strong voice for nurses. The Alliance provides a forum for identification, education, and collaboration building on issues of common interest to advance the nursing profession. Membership is open to any nursing organization whose focus is to address current and emerging nursing and health care issues.

Through the internship, I was able to spend 2.5 days in Washington, D.C. on Capitol Hill learning how to become an effective health care advocate. The goal of this program is to prepare nurses to become involved and

help influence policy at all levels of the government. The attendees had all levels of education, from nursing students to DNPs and PhDs. It doesn't matter where one is in their career; anyone can attend, from novice nurses to those with the highest degrees, or professionals approaching retirement. Advocacy for patients begins from within. The goal of this program is to prepare nurses to become involved and influence policy at all levels of government. Attendees are prepared and excited about advocacy and the legislative process by the end of the meeting.

During the opening, Becky Patton, MSN, RN, CNOR, FAAN, Lead Coordinator of The Nursing Organizations Alliance, heartily welcomed the 92 attending nurses from across the country. Multiple advocates discussed the topic, Addressing Core Issues Facing the Nursing Profession Today, including Suzanne Miyamoto, PhD, RN, Director of Government Affairs, American Association of Colleges of Nursing (ACCN); April Canter, MPA, Associate Director, Government Affairs, American Nurses Association (ANA); and Jo Ann Webb, MHA, RN, Director, Federal Relations and Policy, American Organization of Nurse Executives (AONE)/American Hospital Association (AHA).

NIWI provides an overview of the basics of Congress and the legislative process. Nurses learn about beginning and developing working relations with congressional members and their staffers, in D.C. and in their home districts. Everyone was amazed to find out the best time of the year to meet Senators and Congress members. Every August, legislative members are in their home districts to meet with their constituents, and to work with their home district staff. This is the perfect time for nurses to set up appointments to meet with them.

As we approach the time when finances are very much on the radar in Capitol Hill, our legislators are approached by many people lobbying for their concerns. Because a face-to-face meeting with a Senator or Congressperson is rare, a person who is requesting funding usually takes a short list of requests to a meeting. This items on the list are known as "ASKS." NIWI provided attendees with the 3 ASKS that The Alliance wants nurses to concentrate on, decided by The Alliance based on input from all the members of the organization.

Our 3 ASKS were:

- Support \$251 million for the Nursing Workforce Development Programs (Title VIII, Public Health Service Act). Please make nursing one of your top FY 2013 programmatic priorities.

- Support \$150 million for the National Institute of Nursing Research in your list of FY 2013 programmatic priorities.

- Support \$20 million for Nurse-Managed Health Clinics in your list of FY 2013 programmatic priorities.

Appointments were made by NIWI staff for interns, who were grouped by state, to meet with Senators. Our group met with the health legislative assistants for Senators Barbara Mikulski and Ben Cardin of Maryland. We were given statics to share with the legislative staff, and presented those with our ASKS.

I would never have thought I'd be going to Capitol Hill, but I was proud to have the opportunity to suggest funding for so many healthcare needs that affect my profession of 33 years. It all starts with just one person making a difference. I would recommend to every nurse to get involved and have the chance to say, *I helped make a difference*.

Nurses can find out who their representatives are by logging onto <u>http://www.house.gov/</u> and entering the zip code. To find out who your senator is, log onto <u>http://www.senate.gov/</u>. Send your senator a letter or meet with them when they come back to their home districts in August.

2012 New Orleans International Stroke Conference Update

In this age of instant access to all manner of information, the latest science is readily available at our fingertips. It's easy, purportedly accurate, if accessed from a reliable site, and can be retrieved from your laptop or handheld device. So the question remains, what is the necessity of traveling across the country to hear this data presented? After my trip to New Orleans I contemplated this very question. It quite simply is the human interaction that is lacking from the aforementioned ways of keeping current in your practice. It allows you the opportunity to interact with your

peers, share experiences, protocols, policies, and possibly pitfalls.

Saint Luke's Neuroscience Institute of Kansas City, MO, presented their data and experiences, entitled *Community Comprehensive Stroke Center: Meeting Growing Needs,* authored by Tony Nunn, BSN; Marilyn Rymer, MD, FAHA; and Debbie R. Summers, MSN, RN, FAHA, ARNP.

The three presenters systematically chronicled their journey over the last 20 years into the program they have today. It is organized around Centers of Excellence, which follows the patient through the continuum of care. Several key concepts that were integral in the transformation were the development of a process structure and assuring that you have the complement of personnel to carry these concepts through to their actualization. Development of Clinical Order Sets and Checklists to assure continuity and adherence to protocol is essential. The ten core measures outlined by the Joint Commission in collaboration with the American Heart Association (AHA) and the American Stroke Association (ASA) are all addressed in pathway order sets, educational materials, and discharge instructions. One of the core measures actually addresses the issue of the patient being assessed for rehabilitation, again to assure the continuation of the processes that were initiated in the acute phase of the patient's stroke.

A truly inspirational speaker, Judith Johnson, PhD, RN, FAAN, Minneapolis, MN, presented *Long-term Survivor Experience of Integration Back into Life*. She chronicled her experiences in 1991, as she was suddenly thrust from "wellness to illness," when she sustained an hemorrhagic stroke. In addition to her personal experiences, she shared published data on long term stroke survivorship. A few of the key points highlighted were that, 1) Stroke incidence is rising among younger adults, 2) Overall mean age of stroke is decreasing, 3) Improved survival rate from stroke, 4) Improved Interventions has resulted in reduced severity of symptoms. This data needs to be translated into functional outcomes, therefore ongoing research is essential. If you have the opportunity to hear her speak, don't pass it up. An important concept for us all to remember, is to choose our words carefully in our practice, i.e., *stroke survivors*, not stroke victims; *care partners*, not caregivers, just to highlight a few.

The AHA/ASA, in association with The Joint Commission, will soon be releasing new requirements for Primary Stroke Centers to achieve designation as Comprehensive Stroke Centers (CSC), and the documentation on these processes will become ever more important in the role of the Interventional Radiology Nurse. In the next issue, I hope to address these new metrics.
