


President's Message

The Orientation Manual is under revision. The third edition of the *Core Curriculum* is preparing for publication. The *Journal of Radiology Nursing* is being prepped for the next issue. Hopeful CRN candidates are preparing for the exam or for application to the 2014 exam. Our highly cherished CRN credential is now formally recognized by the ANCC after a lengthy process completed by a dedicated group of nurses. I usually approach most new endeavors as a journey, so when I was asked to be the Director of Education and a new Board member, I took it as an opportunity to spread my wings and learn something new. A Canadian Member's Viewpoint

Since 1951, all Canadians have enjoyed a publicly funded (through tax dollars) healthcare system, which is basically free at point of care. All essential basic care is covered, including vaccinations and screening exams. We have standards mandated by our federal government, even though healthcare is a provincial (state) government responsibility. Free healthcare is a boon to our citizens and ensures patients are never required to skip care due to financial burdens. There is no pre-approval needed for procedures, and ensuring that all necessary pre-procedure blood work is completed is easily done.

Based on my experience on the ARIN list server, I see two significant downsides to the removal of money as an incentive in healthcare. Patient satisfaction is a minor concernit makes no difference which hospital a patient chooses, so there is no incentive to provide better patient care than the next hospital. We do not have patient convenience packages, such as free parking or coffee coupons, to give out. There is no reason to provide new procedures until they have been very well supported in research, so we rarely seem to be pushing the envelope.

Another major downside is that we have nothing resembling "magnet" designation. There is no incentive to the employer to get nurses certified. The three nurses in Canada, who have chosen to become certified radiology nurses, have done so at their own expense and with no increase in wages as a reward. Certification is only for personal satisfaction here.

Canada has a population roughly equal to the state of California. As such, there are relatively few radiology nurses across the country. In my province, radiology is not even listed as a field of care on my nursing license registration. This means radiology nursing education is extremely limited. Although there is a national IR conference held yearly, it does not have nursing-specific programming. Thankfully, ARIN provides nurse-specific conferences twice a year and online webinars to help keep me up to date.

The management hierarchy of diagnostic imaging in my geographical zone has no nurses. As many radiology nurses across both our countries have experienced, nursing is often the forgotten aspect of radiology patient care. Although we do have a national hospital accreditation program, we have nothing resembling JCAHO, and no systematic program that works to improve patient safety. Thankfully, ARIN works so hard to provide clinical practice guidelines, such as the recent joint practice guidelines for sterile technique during vascular and interventional radiology procedures, which help improve safety for all our patients.

Even though my country has very little awareness of radiology nursing and its unique requirements, ARIN supports my every step through education, research, and hosting the extremely valuable list server, where I have a tremendous wealth of information immediately available at my fingertips. My membership in ARIN has greatly improved the care I am able to offer my patients.
