In congressional testimony U.S. Labor Secretary Elaine L. Chao debunked a number of myths, distortions, and inaccuracies about the department's proposal to update the nation's overtime regulations for white-collar workers, saying the proposal will "strengthen overtime protections for millions of low-wage and middle-class workers and empower workers to

understand and insist on their overtime rights. If the Department is blocked from issuing updated, stronger overtime protections, these workers will continue to suffer." Secretary Chao delivered her testimony in front of the U.S. Senate Appropriations Committee's Subcommittee on Labor, Health and Human Services, Education and Related Agencies.

For the first time since 1975, the Department's proposed regulations would raise the salary threshold—below which workers would automatically qualify for overtime—from \$155.00 a week to \$425.00 a week, or \$8,060.00 per year, to \$22,100.00 per year. This increase of \$270.00 a week, or \$14,040.00 per year, would be the largest since Congress passed the FLSA in 1938. The impact of this revision will be to increase the wages of 1.3 million lower-income workers and reduce the number of low-wage salaried workers currently being denied overtime pay.

Other proposed changes include revising job duties required to qualify for the exemption to better correspond to 21st century workplace realities. The old regulations, written in 1949, mention job classifications that no longer exist. Clarifying which job duties qualify for overtime pay will help workers and employers determine overtime entitlement for millions of workers whose status is currently unclear.

Recently, *Vision* had the opportunity to participate in a "virtual interview" with Kathy Scheffer, BSN, RN, CRN, Secretary of ARNA's Board of Directors.

Vision: Kathy, how did you become involved with ARNA?

Scheffer: In 1982, a radiologist I worked with brought back an ARNA pamphlet from the Radiological Society of North America (RSNA). It looked interesting, so I investigated the association. The following year I went to a conference and met a fellow radiology nurse from Seattle, and we formed a chapter to have a local basis for networking.

Vision: What journey did you take through ARNA that led you to becoming a member of the Board of Directors of a national nursing organization?

Scheffer: It all started with my serving as local chapter president of the Northwest ARNA chapter in 1987. I then became the chapter treasurer, and I still hold this position. Both these positions allowed me to become active on chapter committees. I then volunteered for the national nominating committee and attended several ARNA national conferences. Through these conferences, I networked



with other officers and members. During the creation of the core curriculum, I served as editor of the sedation chapter and ran for office as a board member. I was asked to run for the secretary's position and decided it was time to become more involved at a national level. I continue to actively participate with our local chapter because I believe chapters are ARNA's greatest strength. I have enjoyed the past year, serving on the Board, and look forward to the many challenges and opportunities that lie ahead.

Vision: How do you view your role as a radiology nurse, and where do you see the nursing profession going in the future?

Scheffer: I see myself as an advanced practice nurse in a leadership role in radiology. I no longer perform direct patient care but help oversee care and drive policy and protocols that affect all patients in the imaging department. I see this becoming more and more common as radiology nurses continue to advance and more advanced practice nurses are involved

Vision: Where do you see the radiology nursing specialty going in the future?

Scheffer: I was very proud to be the first certified radiology nurse in the northwest and continue to promote certification for all of my staff. Even as we cross train nurses because of nursing and staff shortages, I stand firm in the belief that "specialists" are needed to be the core strength of the imaging team. Knowing the differences in the imaging modalities and procedures can only promote safety and quality patient care.

Vision: How do you think individual ARNA members make a positive influence on practice?

Scheffer: Each radiology nurse can take national standards and apply them to individual work settings. This helps to strengthen the positions of all imaging departments across the country. To have evidence-based practices and research applied to our interventions truly creates the best patient care available. We have a national organization (ARNA) that provides evidence-based recommendations; this gives us great credibility and authenticity to our practice.

Legislation Corner

Legislation Updates and Their Affect on Nursing

n December 2003 President Bush signed into law the Medicare rescription drug Improvement and Modernization Act (MMA) of 2003. This was a Medicare overhaul that includes a prescription drug benefit for eniors, as well as several reimbursement opportunities for hospitals, physicians, and rural providers. This marks the largest wholesale change to he Medicare program since its inception in the 1960s. The total price tag of this bill is over 10 years for about \$400 billion.

'rovisions in the bill include the following:

- Increased payment if new technology is used for inpatient hospital services
- Coverage of category A devices for clinical trails
- Higher payments for services performed for residents with AIDS in skilled nursing facilities
- Cash-flow assistance to critical access hospitals
- Funding for hospitals that serve illegal immigrants
- New appeal right for providers, including the ability to stretch repayments in hardship cases and receive notification for overusing a code
- A quality initiative that results in reduced payments of .04% in fiscal year 2005, 2006, and 2007 to hospitals that fail to furnish data to Centers for Medicare and Medicaid service (CMS)
- The bill is also aimed at attacking fraud and abuse, such as a three-year provision to allow Medicare to contract with private firms for identifying underpayments and overpayments and recouping overpayments.

This bill affects everyone in healthcare organizations, some directly and others indirectly. Not only does it affect patient care, but it also affects patient caregivers in ways you might not have thought, such as the needle stick policy mentioned below.

Public Hospital Needlestick

Several of you are currently working in hospitals with safety needles and sharps. However, there are 26 states that do not recognize the Occupational Safety and Health Act (OSHA) regarding needlestick protections to public hospital workers. The MMA established a new Medicare condition of participation for those hospitals. Beginning July 1, 2004, these hospitals will be required to meet the bloodborne pathogen standard, which requires the use of safety needles and sharps.

In March of 2003, I attended the Nurse In Washington Internship (NIWI) in Washington DC, at which time I met Congresswoman Lois Capps (D-CA), an inspiring nurse on Capital Hill. During my visit, she started to put together a Nursing Caucus. She encouraged nurses throughout the United States to explain the purpose of the Caucus and to get representatives from their state involved in the Caucus. The Nursing Caucus has now grown to over 80 member of Congress.

This new focus on nursing issues in Congress was highlighted when the Nurse Reinvestment Act was signed into law. This bill was passed with bipartisan support in both the House and the Senate. The bill included issues related to the nurse shortage, the aging nurse workforce, the workplace environment, and the need to attract over one million new registered nurses by 2010.

The leaders of the House Nursing Caucus coordinated a letter signed by over 90 members of Congress urging the Appropriations Committee to increase funds for the Nurse Reinvestment Act. The House Nursing Caucus will continue to focus on increasing financial support for all programs aimed at recruiting and retaining more nurses.

Another issue that may be brought up for consideration by the caucus this year is the Institute of Medicine (IOM) which reports a clear link between the nursing work environment and patient safety and recommends improvements in healthcare working conditions that would lead to safer patient care. It's reassuring that a permanent caucus has been dedicated only to nursing issues.

2004 is the presidential election year and even though radiology nurses are a small group, we have enough clout to successfully influence the policy makers who are writing the laws, which influence the development of nursing policies during the 2004 presidential and congressional election. . Please contact your representative to urge him/her to cosponsor The Quality Nursing Care Act of 2004 which will mandate the development of staffing systems in hospitals aimed at ending the widespread practice of healthcare facilities in stretching nursing staff with unsafe patient loads, mandatory overtime, floating to units without training and orientation, and other practices that undermine the delivery of safe, quality care. This act specifically addresses staffing. I encourage you to get involved, take a stand, vote, and if you're not already registered to vote get registered. As a nurse and citizen get involved and make a difference in the nursing community at large.

The ARNA Planning Committee invites you to submit an abstract for a presentation at the 23rd Annual Educational Meeting sponsored by the American Radiological Nurses Association (ARNA) to be held March 31 – April 5, 2005, in New Orleans, LA. We welcome abstracts for presentation and posters from radiological nurses and others on topics in clinical practice, education, administration, research, patient education, and consultation in all practice areas. The focus of presentations should be on innovative, practical approaches that can be used in a variety of settings related to radiological care. Presentations are being sought on topics such as competency development, orientation to radiological care, elements of transition in the current healthcare environment, case management, technological advances, clinical techniques or procedures, outcome measurement, nursing administration/staff development, patient education, and others. Presentations should have an interdisciplinary focus whenever possible.

The education meeting will focus on innovative strategies in radiological nursing, with an emphasis on challenges to be faced in the 21st century. The goals of the meeting are to:

- 1. Enhance the practice of radiological nurses in order to improve the quality of services provided to patients.
- 2. Formulate strategies to foster the role of the radiological nurse as patient advocate and educator.
- 3. Prepare radiological nurses for roles as clinicians, managers, educators, and researchers through:
 - analysis of effective techniques for patient education
 - advances in research strategies and methodologies
 - creative strategies in managing patients
 - identification of current and projected trends in the field
 - application of research findings into practice
 - innovative concepts in clinical practice
- 4. Facilitate networking and professional development of radiological nurses.

Submission Guidelines for presentation:

The Planning Committee will review abstracts for presentation based on the following criteria:

- clarity of description of the content and presentation methods
- importance, depth, focus, level of audience interest
- feasibility of application to a variety of settings
- presenter's professional background and speaking experience
- absence of commercial content
- originality of topic/presentation (has not been presented at other radiological nursing programs)

Keeping the selection criteria in mind, prepare an abstract that is 250 words or less.

One presenter per concurrent session will receive complimentary registration for the educational meeting.

Submission Guidelines for posters:

The Planning Committee will review abstracts for posters based on the following criteria:
