# Secretary's Report

The ARNA Board of Directors has been busy working since the annual convention held in Phoenix. New officers and Board members have settled into their roles and various assignments. Conference calls were held in May, July, and August, and a three-day Board meeting was held in September in Atlanta, GA.

Two new task forces were formed: CRN Certification Preparation Course Task Force and the Radiology Nurse Orientation Task Force. Work has begun on a certification preparation course slated to be held on March 31, 2005, one day prior to the start of the 2005 annual meeting in New Orleans. Kathy Scheffer is serving as chair of the Task Force, and 11 members have volunteered to develop the course. Rhonda Caridi and Debra Beach, ARNA Board members, are also serving on the Task Force. Patrick Glickman is serving as chair of the Orientation Task Force, and the Task Force is gathering information to include in the orientation packet. Both of these projects are designed with the purpose to meet the needs of members while being potential revenue generating sources for the Association.

The Standards Task Force completed the revision of the *Scope and Standards of Radiology Nursing*. The standards were forwarded to the American Nurses Association's Committee on Standards for approval.

The Radiologic Nurses Certification Board (RNCB) is investigating accreditation through the American Board of Nursing Specialties. RNCB has held two test writing sessions and agreed to recertification through contact hours for 2005. The Board also approved the change of criteria to sit for the exam from working in radiology for 4,000 hours in two years to 2,000 hours in a three-year period.

Liaison relationships remain strong and active with reports received from

SIR, PAD, RSNA, AHA, AHRA, ACR, and Nursing Organizations Alliance. A potential liaison to the JCAHO was investigated and will be considered in the future.

ARNA bylaws have been in revision with the vote from the membership targeted at the 2005 annual meeting. The mission statement and goals of the association remain topics of discussion for the Board.

ARNA's two publications: *Vision* and the *Journal of Radiology Nursing* are both progressing and meeting deadline dates for publication. Membership and Board members are encouraged to submit articles for publication to help build the pool of articles available.

A strategic planning session was held for the Board in Atlanta with Glenn Tecker, a nationally recognized futurist and strategist. The Board benefited from planning and setting the vision for ARNA for the coming years. It was agreed that a strong strategic plan would enable the Association to continue to grow and advance in order to meet the challenges that many nursing organizations are facing.

ARNA membership as of October 2004 stands at 1559. The Chapter Committee reports 28 active local chapters. The ARNA Web site is undergoing revision with a launch date of December 31, 2004. It is hoped updating the Web site will be a benefit for the members as well as the local chapters.

## **Five Minutes With Patrick Glickman**

Recently, *Vision* had the opportunity to participate in a "virtual interview" with Patrick Glickman, BSN, RN, CRN, Board member.

*Vision*: How do you view your role as a radiology nurse and where do you see the nursing profession going in the future?

Patrick: I view my role as a radiology nurse to be a combination of patient advocate and nurse anesthetist. I have always worked in the



interventional section of radiology and enjoy it immensely because I came from an ICU background. I worked with patients who had open-heart surgery and enjoyed the freedom of working within physician protocols while taking care of patients. I do that all the time working in IR when I sedate and recover patients.

I see the nursing profession growing even more important in the future as resident physicians have their hours cut back and they get replaced with NPs, PAs, or the latest in this arena: the Virtual ICU. There may not be as many nurses as are needed, but their voices will be stronger.

Vision: Where do you see the nursing specialty in radiology going in the future?

Patrick: I have been a radiology nurse since the early 90s when most of our cases were arterial. We routinely performed percutaneous choleangiography and percutaneous nephrostomy. Our only venous work was with the patients on dialysis. Now cardiologists and vascular surgeons are doing their own arterial work; endoscopists are doing amazing work with ERCPs; and urologists are doing the same with cystoscopy. Our workload has evolved into providing state-of-the-art cancer treatments using chemoembolizations and radiofrequency ablations, treatment for uterine fibroids, and advanced venous access. There will be more imaging equipment in the operative suites, and I believe that we, as radiology nurses, should be the resource for other nurses who find themselves providing care in imaging environments. We should be publishing our body of work so that the OR nurses will be seeking out our literature on the care of patients undergoing image guided procedures. We are the experts in that care.

Vision: How do you think individual ARNA members make a positive influence on practice?

Patrick: It has been my experience that some radiology departments function as if they are somehow separate from the hospital. The radiology nurse is the link from the hospital to the radiology department to ensure that appropriate care is delivered and that policies and procedures are followed. You also have to do that quite tactfully because you are often the most misunderstood person on the team. You are the only person who thinks like you, and the only other people who understand your reasoning are other nurses. You also have to know that change is a slow process and it needs to be cultivated. You can accomplish a lot in delivering safe patient care when you follow the Joint Commission on Accreditation of Healthcare Organizations' (JCAHO) guidelines because everyone is compelled to do so. Implementing changes that you want to make in the delivery of safe care requires the patience of a saint.

## **Five Minutes With Sophia Jan**

Recently, *Vision* had the opportunity to participate in a "virtual interview" with Sophia Jan, BSN, RN, Treasurer.

*Vision*: How do you view your role as a radiology nurse and where do you see the nursing profession going in the future?

Sophia: The nursing profession offers different opportunities to meet an individual's interests from the inpatient to outpatient, from the IR suites to recovery, from administrator to practitioner.

I see radiology nursing as a specialty area and a rapidly expanding field. Currently, I am the nurse manager in the Department of Radiology at the University of Michigan Health Systems. We have over 40 nurses, a nursing supervisor, and a nurse practitioner. A second nurse practitioner is being hired. We are adding additional nursing staff.

We provide pre, intra, and post procedure care as well as patient education prior to and following intervention.

Vision: Where do you see the nursing specialty in radiology going in the future?

Sophia: The rapid growth of interventional and image technology enables our nursing profession to fill new roles in diagnosis and treatment of patients. The specialization requires a staff of highly trained professionals in an environment dedicated to continuing education.

Vision: How do you think individual ARNA members make a positive influence on practice?

Sophia: ARNA members take responsibility for the communication, teaching, and research to advance our knowledge and practice through networking, journal reading, seminars, and publications.

Vision: How did you become involved with ARNA?

Sophia: I joined ARNA in 1984 in order to network with other radiology nurses nationwide. Since we share similar issues and problems, working together enables us to consult and expand our knowledge and practice.

## Certification/Recertification Guidelines Available!

The Radiologic Nursing Certification Board, Inc., (RNCB) and the American Radiological Nursing Association (ARNA) announce that revised guidelines for the certification/recertification exam in radiology nursing are now available.

An important change is that starting in 2006, those sitting for the exam for the first time must show that they have obtained 30 contact hours of continuing education in a 2-year period. Starting in 2004, candidates may choose to recertify by examination or by obtaining continuing education contact hours. Sixty (60) contact hours within a 4-year period are required to meet the contact hour requirement for recertification.

### Note: The practice hour requirement has changed. The following now applies:

Have practiced as a licensed registered nurse a minimum of 2,000 hours in radiology nursing within the past 3 years.

The next exam will be offered August 13, 2005. The deadline for submission of applications is June 30, 2005.

Vision: How did you become involved with ARNA?

Patrick: I was a nurse for 7 years before I took my first job as *the* radiology nurse at Graduate Hospital in Philadelphia. I was comfortable with my nursing skills but as far as tailoring care to patients, I soon realized I was flying by the seat of my pants. Issues started to arise as to what the role of the nurses was during cases in which they were sedating patients. Mind you, my role then was one of giving the first dose of Midazolam and Meperidine and then scrubbing in for the case. I did all my documentation at the end of the case and then called report to the unit. The section chief, Arnold Chait, told me about ARNA, and I started to attend some meetings and conferences to get information so I could change my role at my hospital.

Vision: What journey did you take that led you to becoming a Board member of a national nursing organization?

Patrick: My next job was as assistant nurse manager at Temple University and, after a successful JCAHO inspection, I was promoted to nurse manager. I started to get involved locally, serving on the board and hosting conferences. Temple sent me to the ARNA meeting in San Antonio where I began to meet other radiology nurses from across the country. I also was in contact with Lynn Reid, who was a Board member at that time, and she would often tell me how interesting it was in being involved with ARNA. I moved to the Hospital of the University of Pennsylvania a few years later, became president-elect of the local ARNA chapter, and met the other chapter presidents and national Board members at the conference in Utah. I always had it in the back of my mind that it would be exciting to put my name in for election to the ARNA Board but thought, "Why would anyone vote for me?" With a little prodding I did submit my name when I realized that I, like every ARNA member, have something to offer to the organization. I want this group to grow as our profession grows, and I'd like our group to be the resource for patient care in imaging environments.

The Scholarship Committee is revising the application process to enable greater participation from members.

The revision of the Core Curriculum, with Colleen Sasso's leadership, continues to work on chapter development and revision. Chapter captains have been designated and drafts have been submitted for first review.

The Nominating Committee, with Kate Little as Chair, has solicited members to run for upcoming vacant positions of President Elect, Secretary, and Board member. Candidate biographical information is being collected so a ballot can be mailed out to the membership in January.

The Planning Committee is completing program development and speaker designation for the 2005 ARNA Annual Meeting in New Orleans. Thirty-two abstracts were received. GE Healthcare has agreed to sponsor the opening speaker and the opening joint session will focus on Legends in Radiology.

The Board continues to meet monthly and a winter board meeting will be held in January to continue to work on advancing ARNA's projects and goals and to finalize plans for the 2005 annual meeting.
